This is to certify that M/s.Prince Foundations Ltd., have constructed MSB comprising 2 Blocks, consisting combined Triple Basement floor + combined Stilt Floor + combined 1<sup>st</sup> floor with Tower-1 2<sup>nd</sup> floor +17<sup>th</sup> floor and Tower-2 - 2<sup>nd</sup> floor to 18<sup>th</sup> floor Residential Building with 155 dwelling units at Door No.100, 101 & 102, Poonamallee High Road, Egmore, Chennai - 600008 in R.S.No.799, 800/1, 800/3,800/5 & 803/2, Block No.37 of Egmore Village within the limit of Greater Chennai Corporation sanctioned in P.P.No.C C/PP/MSB/51AtoN/2015, Permit No.9041 in Letter No.C3(N)/18150/2013 dated 17.12.2015 and it was inspected and observed that the building has been completed as per approved plan and satisfies the norms for issue of Completion Certificate approved by the Monitoring Committee.

- 2. Accordingly Completion Certificate is issued for the above construction in C.C.No.EC/Central-I/158/2017 dated 23-06-2017.
- 3. In accordance with the Provisions of the Town & Country Planning Act, 1971 and the Rules made there under. This Provision does not cover the Structural Stability aspect of the building. As far as the Structural Stability aspect of the building is concerned, it falls within the jurisdiction of the Local Body concerned as stated in the connected Building Rules under the respective Local Body Act, 1920, such as Madras City Municipal Corporation Act, 1919, Tamil Nadu District Municipality Act, Tamil Nadu Panchayat Act. The Completion Certificate issued under Development Regulations 4(5) does not cover the Structural Stability aspect. It is the sole responsibility of the Applicant/Developer/ Power Agent and the Structural Engineers/Licensed Surveyor/Architects, who has signed in the Plan to ensure the safety after construction and also for its continued Structural Stability of the buildings.
